NO. KV.38 of 2008 NPL/1007/1454/M :- In exercise of the powers conferred by sub-section (1) of section 104 read with section 99A of the Gujarat Municipalities Act, 1963 (Guj. 34 of 1964) the Government of Gujarat hereby-

- (i) empowers the municipalities to levy the tax on buildings or lands based on carpet area, and
- (ii) fixes the minimum and maximum rate of tax as specified in column (2), (3), (4) and (5) of the TABLE below for the class of municipalities respectively specified in column (1) of the said TABLE.
